- 3.During our August 16, 2016 telephone conversation, Detective Klohr advised me that he had spoken with Shavaughn McKenzie. As a result of that conversation, Detective Klohr suggested to me that Ms. Jenner file a request for a civil harassment restraining order against Mr. McKenzie.

On 08/14/16 at approx 2000 hours, my partner (Ofer Menier #42283) and I (Ofer Williams #36523) was assigned to Hollywood Unit 6A77-W3 driving a marked black & white in full uniform. We received a radio call of a Trespass Suspect there now at

Comments of the call read: Susp M/B. stalker of Kendail J (Confidential). Susp has followed her through the driveway. She is in her veh, unable to go inside. Inc

Investigation:

While officers were enroute to the radio call, a supervisor was requested to respond to the scene based on the comments of the call. Unit 6L50-W3 (Sgt Cabunoc #35421) responded.

Upon arrival at the location, the Susp was seated on the curb at the S/W curb of

The Susp was taken into custody without incident. While being detained, the Susp spontaneously stated, "All I was trying to do is talk to her. It's not like I had a gun."

Ofer Menier interviewed the Vict - Kendall J (Confidential), who provided the following statement. She was driving home when she noticed a male/Black (later identified as Susp - McKenzie) sitting on the curb next to the gate to her residence. Vict did not recognize the male immediately and continued to her residence. Vict was cautious while entering her property to make sure the male did not follow her into hea residence. As Vict watched the gate closing to her property, she did not observe anyone enter her property. Vict was getting out of her vehicle when she noticed the male behind her car. In fear for her safety, Vict returned to her vehicle & locked the door to get away from the male. Upon seeing the male that was on her property, she recognized it was the same person who had previously been sitting on the ourb outside her property. Vict then realized that this was the same male with whom she has had previous incidents of harassment at her former residence. In fear that the male may hurt her or have a weapon, the Vict contacted a friend (later identified as PR - Azoff) to help. The male began striking his fists on the vehicle windows causing the escalation of the Vict's fear for her safety. Susp asked Vict, "Can I talk to you?" Viet told the male on multiple occasions to leave. The male refused to comply with her request. Vict was advised by PR - Azoff to stay in the vehicle and leave the residence. PR - Azoff then told the Vict that he was going to contact Police. The Vict then drove off her property. The male began to follow her as she left the location while she was operating her vehicle. As the Vict drove away, (2) males (later identified as Boyce Lion and Tyler Okonma) made contact with her. The Vict directed the (2) males to the location of the Susp, who then had him sit on the curb at until PD arrived. REDACTED

Vict advised that the Susp has made multiple attempts to contact her. Vict stated that the Susp was escorted away from her residence by building staff at her former residence on more than one occasion. Vict also stated that on one occasion the Suspect ran into traffic and tried to chase her down while she was operating her motor vehicle during a previous incident.

Ofer Menier then interviewed the PR - Azoff, who stated the Vict called him frantic & scared. She stated that there was a male on her property refusing to leave. Azoff advised the Vict to stay in her vehicle and to

leave her property to get away from the male. Azoff advised the Vict, he would contact police. Upon his arrival to the Vict's location, Azoff helped keep the distance between the male and Vict until the police arrived to detain the male. During the course of Azoff's conversation with the Vict, Vict identified the male as an individual with multiple prior contacts causing her to be in fear of him. Vict identified the male to Azoff as "The Stalker."

Ofer Williams interviewed the Susp while at scene. Suspect stated that he was sitting on the curb outside of the Vict's residence. The gate across the driveway to the residence was closed. Upon observing the Vict's vehicle, the driveway gate opened and the vehicle entered the residence driveway. The Suspect then followed the vehicle onto the residence.

Upon the vehicle coming to a stop, the Susp proceeded to the front of the Vict's vehicle while the Vict was still seated in it. The Vict started to scream and the Susp in an attempt to calm her stated, "Hey look, don't have a gun." The Susp then put his hands up in an attempt to calm the Vict, and turned in a circular motion while still standing in front of the vehicle to show his entire waistband to the Vict. The Susp was standing between where the Vict had stopped her vehicle and the front door to the residence preventing the Vict from entering her house.

The Victim then backed out of the driveway, and the Susp followed her off the Vict's property. The Vict remained inside of her vehicle, but did not drive away from her residence. Approx (5) minutes later, a male/White arrived (later identified as PR-Azoff) and the (2) males were standing in the street. All (3) males remained at scene, directing the Susp away from the Vict's vehicle, and had the Susp sit until PD arrived at scene until he was taken into custody.

The Susp continued by spontaneously stating that he had met the Vict approx. (6) weeks prior to the incident. The Susp used to wait outside of her apartment and attempted to "chill" (have a conversation) with the Vict. On one occasion, the Susp stated that the Vict contacted Police to respond to the location, but the Susp fleet spea maliring the Vict contacted PD. The Susp did not know the location of the Vict's former residence.

The Susp stated, "I just wanted to have a conversation with her (Vict), but everything just went wrong. If she could just see what a chill guy I am, I know she'd want to be with me."

The Vict signed a Private Persons Arrest form for Trespassing, and the Susp was transported to Hollywood Station. A want/warrant check of the Susp's personal information revealed that he had an outstanding Trespass Warrant for \$30,000, and approx. (8) prior arrests for Trespassing. None of the other arrests involved the Vict. Also, the Susp had a narcotice arrest from Florida in 2011. A review of the Susp's criminal history revealed that the Susp was on Summary Probation for 602(K) P.C. – Trespass until 04/29/2019.

### Statements:

Susp waived Miranda upon Admonition (LAPD 03.11) and made the following statements:

Officer Williams stated, "You've already told me what happened tonight while we were out at scene. I just want to go over a few other items related to your situation. You are from Florida, why did you move to California?"

Susp responded, "I moved to Calabasas to be with family & friends. I don't remember when I came here, but I got kicked out after a couple of weeks. I've been "chillin" in the Venice (Venice Beach area in LAPD Pacific Division) area since then.

Officer Williams asked, "Since then have you attempted to speak with Kendall (the Vict)?"

Susp responded, "Yeah, I would wait outside of her apartment sometimes. I tried to talk to her once, and got scared when she threatened to call the police. Every time, I just want to talk to her. Something always goes wrong. That's all."

Officer Williams then asked: "So there's been more than one time prior to tonight that you've tried to talk to her."

Susp responded, "Yeah, no. I've only tried to talk to her once, but I've been outside of her apartment a lot."

Officer Williams asked, "All the other times you were arrested since moving to California, did any of them involve Kendall?"

Susp responded, "No. I was just trying to chill and sleep."

Officer Williams asked, "How did you find out where Kendall lives?"

Susp responded, "Yeah, I really don't want to get into that. If I could just spend some time with her, then we could chill."

Susp then refused to clarify or provide any further statements regarding the incident.

## Investigation (continued):

Based on the Vict's demeanor at scene, who appeared to be in fear of the Susp and would not exit her vehicle even after PD had detained the Susp & placed him in the patrol vehicle. The Vict signed a Private Persons Arrest form, and advised that she intended to have a legal representative of hers obtain a Restraining Order on her behalf. Additionally the Susp had an outstanding warrant for Trespessing, and is currently on Summary Probation for Trespessing until April 2019. Lastly, the Susp has had an unknown exact number of contacts with the Vict causing her to be in fear of the Susp including the Susp running into the street to chase the Vict's vehicle and the statement that the Susp did not have a gun on his latest contact with the Susp. Susp was arrested for 646.9(a) P.C. – Stalking and the outstanding Trespess warrant.
